Certification Fees

The Department of Health (DOH) Office of Health Care Assurance (OHCA) has some important updates and requirements for all facilities for calendar year 2019 and beyond.

1. Licensing/certification Fees: Per the adoption of Title 11 Chapter 103 Hawaii Administrative Rules (HAR), the OHCA will begin collecting licensing/certification fees for all healthcare facilities prior to issuing new licenses/certifications or renewing licenses/certifications. - \$300 Initial
 - \$200 Renewal
- c. Adult Residential Care Home Type II (including Exp.):
- \$300 Initial
 - \$200 Renewal
- d. Assisted Living Facility:
- \$600 Initial
 - \$400 Renewal
- e. Community Care Foster Family Home:
- \$150 Initial
 - \$100 Renewal
- f. Developmental Disability Domiciliary Home:
- \$300 Initial
 - \$200 Renewal
- g. Home Care Agency:
- \$1200 Initial
 - \$900 Renewal
- h. Special Treatment Facility/Therapeutic Living Program:
- \$300 Initial
 - \$200 Renewal

IMPORTANT NOTE: IF YOU CURRENTLY HAVE A LICENSE/CERTIFICATION, YOUR FIRST FEE WILL BE A RENEWAL FEE, NOT AN INITIAL FEE.

Invoices for licensing/certification fees will be sent by the OHCA via mail for facilities that have a license/certification renewal date of **May 1, 2019**

and later.

If your facility license/certification has already been renewed, or is scheduled to be renewed before May 1, 2019, you will **NOT** have a fee for 2019.

Do not send in payment to the OHCA until you receive an invoice. The invoice will identify the licensing/certification fee you owe and when payment is due.

Note: Licenses/certificates will NOT be issued until payment of fees is made to the OHCA. License/certification length will remain the same as they have been.

For CCFHs, this means that if you do not pay your certificate fee, you will not be certified and will not be allowed to operate past your current renewal date. Your certificate will expire if you do not pay the fee.
