CTA is distributing this information which is approved by the Office of Health Care Assurance. It is being distributed to all ADCCs, CMAs and CCFFHs.

This is an update to all previous Vaccine update newsletters.

Update January 8, 2021 for Adult Residential Care Homes (ARCH), Community Care Foster Family Homes (CCFFH), Developmental Disabilities Domiciliary homes (DDDh), Developmental Disabilities Adult Foster homes (DDAF) and Developmental Disabilities (DD) waiver clients.

See new information below on vaccination and clinic planning.

This email update is intended for the facilities and providers included in the U.S. Center for Disease Control and Prevention (CDC) vaccination group 1A. For facilities/licensees that do not appear in the above list, you will be included in later groups and will receive a separate email. The Office of Health Care Assurance, Department of Health, Department of Human Services and the Hawaii Emergency Management Agency do not have authority to designate facilities in the CDC group 1A. As a result, OHCA licensees that are included in later groups will be addressed separately.

1. Facilities on Hawaii Island: Drive-thru vaccination clinics and home visits are being coordinated between the Department of Health District Health Office (DHO) and KTA for January and February. Here is the schedule:

a. First (1st) Dose:

- i. Friday, January 15: Hilo Civic Center; 8:30 am to 2:30 pm
- ii. Friday, January 22: Kona Community Aquatic Center; 9:00 am to 1:00pm
- iii. Monday, January 25: Pahoa Gym; 9:00 am to 1:00 pm
- iv. Friday, January 29: Hilo Civic Center; 8:30 am to 2:30 pm

b. Second (2nd) Dose:

- i. Friday, February 12: Hilo Civic Center; 8:30 am to 2:30 pm
- ii. Friday, February 19: Kona Community Aquatic Center; 9:00 am to 1:00 pm
- iii. Monday, February 22: Pahoa Gym; 9 am to 1:00 pm
- iv. Friday, February 26: Hilo Civic Center; 8:30 am to 2:30 pm

c. In-home vaccination visits will be conducted between January 16 and January 21, 2021.

2. Facilities on Oahu: Times, 5 Minute Pharmacy, Pharmacare, Foodland, Queen's, and ElixRx pharmacies have agreed to perform in-home visits to 100% of CCFFH, ARCH, DDDh, and DDAF providers on Oahu. These pharmacies will be administering both the first and second doses of the vaccine. Different pharmacies will be covering different areas of Oahu. The first doses will be administered between January 17 through January 30, 2021. The second doses will be

administered between February 14 through February 27, 2021.

3. Pre-registration Required: To schedule a vaccination appointment, select the clinic below.

4.Consent Form Required: Please click <u>here</u>to fill out the online consent form OR fill out and print the attached form fillable consent form and bring it to the clinic. The consent form must be completed by all care givers and residents who will be receiving the vaccine. If a resident has a designated legal guardian or Power of Attorney, they must also sign the consent form.

5. On the Day of the Clinic:

- Arrive at the clinic location you have selected at your scheduled time.
- Follow signs and/or instructions when entering the clinic site.
- Bring the following:
 - Government issued picture I.D.
 - Medical insurance card
 - Printed consent form if you have filled out the form fillable consent form.
- Wear a face mask. Face masks are required.
- You will be screened for signs/symptoms of COVID-19. If you are not feeling well, do not attend the clinic.
- The vaccine will be administered by a medical professional with training on injectable medication administration and possible reactions to the vaccine.
- You will receive your vaccination in your upper arm. Wear attire which will allow the immunizer to easily administer your vaccine.
- You will be required to stay on-site for at least 15 minutes after receiving your vaccination to monitor for any adverse reactions.
- A staff member will schedule your second dose after you are vaccinated.
